Significant Events, Projects and Happenings at Caritas Czech Republic in 2019

HOME IS HOME: CAMPAIGN TO RESCUE HOME HEALTHCARE

Home healthcare nurses went on strike in August 2018. This form of care is prescribed by physicians and, according to the law, must be fully covered by health insurance. In fact, **an unfairly regulated system of reimbursement from insurance companies withdrew the salaries of nurses in home healthcare far below the national average of nurses' pay and providers were receiving payment for approximately 60% of their work.**

Therefore, the objective was to obtain full payment from health-insurance companies every month for the work that the nurses actually do.

Following a series of unsuccessful negotiations with the Minister of Health and representatives of health-insurance companies, the nurses' representatives therefore went to the Ministry of Health building on 1 May 2019 and tied red ribbons to the trees there; with this gesture

on Labour Day, they addressed the head of the ministry, Adam Vojtěch, and demanded his support. The nurses adopted the red ribbon as a symbol of their demands at the beginning of April: it expressed the ties between nurses and patients, as well as their tied hands. It also symbolised a sort of notional red line that had been crossed.

In the meantime, the Home Care Association, the Czech Association of Nurses – Home Care Section and the specialised association Gratia Futurum 913, i.e. the providers of 98% of this form of care, together with Caritas, also became involved in the dispute. However, as none of the other negotiations had ended in an agreement, Caritas Czech Republic launched a campaign called **Home is Home** at the beginning of July and published an online call and **petition to**

save home healthcare. The response was tremendous – in seven weeks, 36,000 signatures were collected under the petition, i.e. three times more than is required for submission to the Committee on Petitions of the Chamber of Deputies. It was also supported by a number of important people: in addition to Archbishop Jan Graubner and trade-union leader Josef Středula, for example, Vice-President of the Senate Miluše Horská, Senators Šárka Jelínková and Herbert Pavera and former Minister of Health Zuzana Roithová. Actors Filip Tomsa, Jiří Mádl, Veronika Khok Kubařová, Dana Batulková, Vanda Hybnerová, Zlata Adamovská and Alena Mihulová, who played the lead role in the film Home Care, also lent their support.

By 30 September, a total of **70,086 citizens had signed the petition.** Thanks to this wave of

support, representatives of home healthcare succeeded in receiving a public hearing before the Committee on Petitions of the Chamber of Deputies in early October – and after a series of very demanding and tense subsequent negotiations with the prime minister and minister of health in attendance, **they achieved implementation of changes to the compensation decree for the following year.** At the same time, strong support was provided to home-care represent-

atives by healthcare unions led by Dagmar Žitníková. In addition to a better points-based performance evaluation, **a CZK 10,000 increase of home healthcare nurses' super-gross salary and backpay resulting from the unfair regulations for 2018 and 2019 were also negotiated.** This step should ensure the rescue and stabilisation of this long underfunded, yet very effective area of public healthcare. “We are touched by how many people

have stood up for the work of the nurses who provide home care for the sick. They are great professionals whom we value immensely. We would also like to thank our employees and sympathisers who supported the nurses in their protests. In this difficult situation, it was confirmed that we are one big charitable family,” said Lukáš Curylo, director of Caritas Czech Republic, **in November 2019, when the nurses' strike could be brought to an end.**

PROJECTS

Towards Quality in Caritas II

September 2018 – August 2020

CZK 6,966,107.10 (European Social Fund, Operational Programme Employment)

A project focused on **improving the quality of social services provided by Caritas in individual archdioceses and dioceses**, enhancing the expertise of employees through a **network of methodological support in the form of a specialised committee and increasing the prestige and awareness of the offer and character of social work**. In 2019, methodologists undertook consultations on quality standards in 103 social services and 35 of them underwent audits or additional related consultations. In total, **support was provided to 324 social-service employees in the scope of 2,947.75 hours**. **Three roundtable discussions** focused on resolving urgent social issues, specifically **Health**

and Social Frontiers in Social Services, People for Whom No Suitable Assistance Exists and Child Protection System, were intended for the broader expert public; the results of the discussions were received by the relevant institutions. **An internship of 22 workers in charitable social services** focused on the transfer of good practice was held starting in September; a video and a leaflet providing information on the offer and character of social work were also created.

FEAD

October 2016 – September 2020

(FEAD, Ministry of Labour and Social Affairs – Operational Programme Food and Material Assistance)

The provision of **food and material assistance to people and families in need** financed with resources from the Fund for European Aid for the Most Deprived (FEAD) and from the state budget through the Operational Programme Food and Material Assistance continued. In addition to basic foodstuffs, hygienic and

household items, textiles, tents, sleeping bags and mats were provided, as was **counselling in difficult life situations and activation services for families with children**. The distribution of aid is coordinated by Caritas Czech Republic in cooperation with Diocesan Caritas organisations. In 2019, more than 30,000 people repeatedly received food aid and nearly 20,000 people received material aid.

MILITARY FUND SOLIDARITY

In connection with the public collection for the Czech Republic, we administrate the Military Fund Solidarity, which is intended to **support the children of soldiers who perished in the line of duty at home or abroad**. The fund also provides **assistance to active-duty soldiers who have suffered severe injuries, serious illness or a death in the family**. Caritas Czech Republic administrates an **extensive database of corporate and individual donors** who contribute to the fund and **collaborates closely with the fund's committee in the preparation of donation agreements and provision of financial assistance**. In 2019, we administrated **14,561 donations in the total amount of CZK 5,888,844.82; CZK 649,589 was distributed in the form of donation agreements**. The Military Fund Solidarity publishes a separate annual report, which is available at www.fondsolidarity.army.cz. We would like to thank everyone who works with us to provide assistance to those in need via this fund.





EVENTS

In cooperation with the Czech Bishops' Conference and thanks to funding from the Renovabis Foundation, we held a breakfast for journalists on the topic of **We Are with People or Why Are Our Counselling Centres Always Full?** on **19 June**. Those appearing at the event included Lukáš Curylo, director of Caritas Czech Republic, Stanislav Přebyl, general secretary of the Czech Bishops' Conference, and Radima Ivančicová, head of the counselling centre at the St. Theresa Shelter Home in Prague. **We annually help nearly 35,000 people free of charge at 69 counselling centres.**

- In the spring part of the **Food Collection**, **212 tons of food and 23 tons of drugstore goods** were collected on **18 May**; the autumn

collection on **November 23** yielded a record **330 tons of food and 52 tons of drugstore goods**. Non-profit organisations and thousands of volunteers and employees of stores take part in the collection, which is one of the biggest charity events. Non-profit organisations use donations for seniors, single mothers, foster families, children from children's homes, the disabled, the homeless and other people in need.

- The nationwide **A Night Outside Campaign** aimed at supporting homeless people took place in 15 cities on **21 November**.

- **The Czechs for Sri Lanka concert**, at which the Bohuslav Martinů Philharmonic Orchestra of Zlín performed under the direction of Indian conductor Debashish Chaudhuri, took place on **1 June** at the Hilton Hotel in Prague under the auspices of Foreign Minister Tomáš Petříček. The event was organised by the Czech Centres in cooperation with Caritas Czech Republic **in response to terrorist attacks by Muslim radicals on Easter Sunday in Sri Lanka**, which claimed 260 lives and injured more than 500.

Proceeds from the concert in the amount of **CZK 347,767 (USD 15,000)** were donated to the families of the victims of the attacks via the partner organisation Caritas Sri Lanka.

- Caritas presented its **activities at home and abroad** at the traditional presentation of non-profit organisations **NGO Market 2019** on **10 April** in Prague.

- **On 4 and 5 July**, visitors to the Caritas tent found themselves in a comic book of good deeds during the **Days of Good Will in Velehrad**.

The mouths of life-size Caritas characters emitted speech bubbles with interesting stories describing service-related experiences and meetings with people who have the courage and strength to help others. As is tradition, the presentation was prepared by the Olomouc Archdiocesan Caritas.

- In his message, Pope Francis urged Christians **to give poor people hope**. Caritas Czech Republic joined the call: the **World Day of the Poor** fell on **17 November** in 2019.





Significant Events, Projects and Happenings in the Dioceses in 2019

BRNO DIOCESE

The Brno Diocesan Caritas worked on the development of a charity rescue network project intended for people in the greatest need. • At a cost of CZK 50 million, the Jihlava Caritas converted a vacated apartment building into a modern Social Services Centre. • The Třebíč Caritas organised a conference on the topic of Where Recidivism Happens and How to Handle It. • The Brno Caritas organised the first meeting of volunteers called DOBROpiknik. • The new Day for Charity donation project familiarised the public with the stories of everyday heroes, employees of the Brno Diocesan Caritas.

ČESKÉ BUDĚJOVICE DIOCESE

The České Budějovice Archdiocesan Caritas began to support young people's interest in volunteering through the YoungCaritas project. • Its Long-Distance Adoption project in Zimbabwe celebrated ten years in existence. It is now changing the name to Donated Home and is transitioning from adoption of a particular child to support for an entire children's home. • The Jindřichův Hradec Caritas opened new premises housing the Kompas low-threshold facility for children and youths, a counselling centre for people in need and a social activation service for families with children. • The Písek Caritas opened new premises for home healthcare, a care service and a volunteer centre.

HRADEC KRÁLOVÉ DIOCESE

Caritas Day commemorated St. Agnes of Bohemia with a worship service and lecture programme. Twenty-three nurses, social workers and administrative workers were recognised for their selfless service to the sick and needy. At the seventh edition of the Meeting of Nations festival, twenty-five countries presented their national dances, music, art and cuisine. • Anna Maclová became the new director of the Hradec Králové Diocesan Caritas. • The Diocesan Caritas launched the Dekacert CZ educational project aimed at supporting the identification of charity workers with Christian values. The project received financial support from

the Renovabis Foundation. • Another charity project in the diocese involves support for the integration of foreigners and persons granted international protection in the region into mainstream society. • The newly opened House of St. Agnes in Hlinsko provided facilities for social therapy workshops, a care service, personal assistance and a social activation service for families with children. • A palliative outpatient facility began operations in Holice near Pardubice. • New hospice and palliative care counselling centres in Trutnov and Náchod provide assistance and support for the terminally ill and their loved ones. • The Polička Caritas has a new contact point for the civic counselling centre in Bystrá. • The Přelouč Caritas opened the Jakub klub 18 low-threshold facility for children and youths. • The Jičín Caritas opened a branch of the social activation service for families with children in Nová Paka. • The Veronika Laundry social enterprise of the Jičín Caritas created four jobs for disabled people.

LITOMĚŘICE DIOCESE

The Litoměřice Caritas completed its counselling centre project. • The Lovosice Caritas renovated the building of the shelter for mothers with children. • The Ústí nad Labem Caritas opened the Home of the Holy Mother containing facilities for a field programme, a low-threshold facility for children and youths and a social activation service for families with children. • In a carpentry workshop, the Česká Lípa Caritas refurbishes and modifies donated furniture for further use. • The Most Caritas provides assistance through five social services in the newly renovated Social Assistance Centre.

OLOMOUC ARCHDIOCESE

The Vyškov Caritas opened the Bohumír Bunža Community Centre with a day-services and personal-assistance centre. • In the garden of the Světlanka day-services centre, the Svitavy Caritas planted the Olga Havel Orchard and organised the Back of the Orchard music festival • Caritas has been providing home hospice care in the area of the archdiocese for more than 20 years. In 2019, the Olomouc Caritas began providing mobile hospice care outside of the Olomouc district. • The Přerov Caritas opened the Lorenc low-threshold day centre for homeless people. • In Rožnov pod Radhoštěm, the Triumf low-threshold facility for children and youths was established with support from employees of the Valašské Meziříčí Caritas.

OSTRAVA-OPAVA DIOCESE

The Jeseník Caritas began the renovation of the St. Francis Home of Peaceful Old Age. • Care providers from the Odra Caritas received three new vehicles. • The Opava Caritas organised the eleventh edition of the My World photography competition intended for employees, volunteers and clients of Caritas throughout the country. • The Studénka Caritas completed the construction of a warehouse for compensatory aids.

DIECÉZE PLZEŇ

The new Horšovský Týn Community Centre provides space and facilities for cultural and social events, social work and community gatherings. It also provides tutoring for children and meetings of mothers in difficult life situa-

tions. We celebrated a number of anniversaries: ten years of the St. Paul Seniors' Home, the day-care centre and Pohodička social therapy workshops, 25 years of the Karlovy Vary Caritas, 20 years of the Home for Mothers with Children in Need in Domažlice, and 20 years of the St. Elizabeth Seniors' Home in Plzeň.

PRAGUE ARCHDIOCESE

The Prague Archdiocesan Caritas renovated a dilapidated building in Třeboradice and converted it into four small apartments for socially disadvantaged families. • Indian families affected by the August flooding received food aid, household furnishings and new housing. The aid was dispatched to the state of Karnataka, where Czech donors support the education of children in the Long-Distance Adoption@ programme. • The Magdala counselling centre, which is focused on helping victims of violence, celebrated 20 years in operation. • Caritas in the Prague Archdiocese celebrated the centenary of its establishment with a benefit concert at the Municipal House in Prague. • The Starý Knín Caritas opened a barrier-free day-care centre in Dobříš for children with disorders on the autism spectrum. • The Slaný Caritas built a new facility for the work of volunteers and material assistance for the needy. • The Kralupy nad Vltavou Caritas purchased and renovated a building in the city centre. The original playroom was replaced with social services to help socially disadvantaged families, social housing and a café. • In the Senate, the care service of the Neratovice Caritas received a Quality Award in social care in the category of field social services for seniors.



Three Kings Collection

The Three Kings Collection, the largest and most successful collection event in the Czech Republic, took place from 1 to 14 January 2019. A total of 66,000 volunteers, both children and adults, took to the streets and succeeded in collecting CZK 119,184,353 in officially sealed cashboxes. The total proceeds of the collection, after figuring in donor SMS and other financial donations to the collection account, amounted to CZK 122,301,607.

The collected funds are **used for people in need and on the margins of society** – seniors whose homes are visited by Caritas caregivers and nurses, mothers with children in need who are seeking to regain their balance in shelters, people with disabilities who visit Caritas care centres, homeless people in Caritas dormitories and seriously ill people in home care and hospice care, as well as families who have found themselves **in an extraordinarily difficult life situation**, e.g. because of a fire or flood. Part of the proceeds goes to **foreign projects** aid at helping people in need who are facing the consequences of military conflicts or natural disasters, or who are living in the difficult conditions of developing countries.





The proceeds are distributed every year according to the same key and clear, predetermined rules: 65% of the amount is returned to the Caritas organisation that raised it, 15% is used for Diocesan Caritas projects, 10% goes to help people in need abroad and to the crisis fund, from which it is drawn during extraordinary events, 5% is used for nationwide projects and 5% covers the collection's overhead as required by law.

During the collection period, the broadest range of events are organised for the public and for the carollers, e.g. parades of the Three Kings, blessings of carollers, concerts, exhibitions and skating for children. These events culminate with the **Three Kings Concert** broadcast live on Czech Television: viewers who watched it on 6 January 2019 contributed **CZK 1,266,495** to the collection account by means of DMS.





Volunteers

Without tens of thousands of willing people who decide to dedicate part of their time, energy and skills to the benefit of others, all free charge, it would be nearly impossible to conduct and provide the activities and services of Caritas Czech Republic.

Over the course of 2019, a total of **72,646 volunteers** helped within the entire Caritas organisation, which is slightly fewer than in the preceding year, though each volunteer accounted for more hours on average. Altogether, **they dedicated 505,343 hours of their time** to their selfless work, which corresponds to 21,056 days, i.e. nearly 58 years!

Traditionally, the largest number of volunteers work with Caritas on the days when the **Three Kings Collection** is carried out. In 2019, there were 66,096 carollers of all ages and organisers who donated **296,751 hours of their time** to the collection – i.e. 12,365 days, or more than 34 years.

AMONG OTHER THINGS, CHARITY VOLUNTEERS:

- visit clients in their homes, talk to them, read to them, cook, play board games with them and carry out memory training with them.
- accompany them during meetings at government offices and, for example, when visiting their friends and acquaintances, and travel with them on excursions.
- paint, play music and make handicrafts with mentally disabled people.
- help clients of all ages and with various disabilities by means of canine therapy and hippotherapy.
- tutor children, particularly those from socially disadvantage families and marginalised locations, and spend meaningful free time with them.
- help children in after-school clubs, assist with the preparation and management of children's camps.
- ensure for Caritas facilities administration and technical agendas (legal, editorial, IT, maintenance and gardening work, and take part in food distribution, help with organising cultural and sporting events, etc.
- participate in the organisation of food and clothing drives.
- assist with transporting clients to Sunday religious services.
- tutor foreigners and assist with translating and interpreting.
- correspond with prisoners.
- produce gifts, greeting cards, etc. for lonely seniors.

A total of **2,616 volunteers took part in these and other activities on a long-term basis and 3,903 volunteers on a short-term or one-off basis.** They dedicated to people who needed their help a **total of 207,723 hours of their time**, which is equal to 8,655 days, i.e. nearly 24 years! This also includes **31 volunteers who donated 896 hours to Caritas in connection with crisis assistance.**

Social and Healthcare Services

The primary mission of Caritas Czech Republic is to provide social, healthcare and social-prevention services to people who have found themselves in an acute emergency or difficult social situation, the disabled and terminally ill, homeless people, prisoners, drug users, and victims of domestic violence and human trafficking, as well as to everyone affected by extraordinary events such as floods and fires.

We protect the interests of the disadvantaged and vulnerable

Thanks to the broad scope of operations and based on our many years of experience, **we participate in the adjustment of the system of social and healthcare services and legislation pertaining to the social field.** In doing so, we always strive to defend the interests and benefits of the clients with whom we work, as well as other disadvantaged or vulnerable people. At the same time, we look after the needs and interests of the Caritas employees who strive

to assist them. Representatives of Caritas serve in working groups of ministries and cooperate with other institutions and organisations both in the Czech Republic and elsewhere in Europe – for example, with the European Anti-Poverty Network (EAPN Czech Republic), Platform 10, Platform for Social Housing and the Union of Employers' Associations.

In 2019, our advocacy activities were focused on **debt issues** in an effort to improve conditions for employers, debtors and creditors. Another major topic was the need for a **comprehensive solution for the socio-healthcare issue**. In addition to that, we began striving for the **implementation of the legislative enshrinement of so-called street medicine**, i.e. healthcare provided in the field.

In cooperation with **Caritas Europa**, we prepared the Caritas CARES 2019 report on the availability of services in the Czech Republic from the perspective of Caritas. Several of our employees also took

part in Caritas Europa's working groups focused on development cooperation, migration and the fight against poverty and social exclusion.

We care very much about the high quality of social services: the two-year **Towards Quality in Caritas II** project involving methodological support for services contributes to the improvement of those services (*see page 4 for more information on the project*). In connection with the project, we carried out consultation on the quality standards in 103 Caritas services and organised eight specialised committees for methodologists in 2019. There were also three roundtable discussions for the expert public, the output of which comprised expert reports that also serve as a **basis for the advocacy activities of Caritas Czech Republic**.

For Caritas's work, it is necessary to share good practice and to cultivate a common opinion.

Meetings of the committees at the diocesan levels and at the national level help to achieve this. These committees comprise a specialised platform for workers from the same fields and represent an opportunity for consultation and proposal of new steps. In the social and healthcare fields, **nine specialised committees work at the national level:**

- Committee on shelters for mothers with children in need
- Committee on migration
- Committee on counselling centres
- Committee on social activation for families with children
- Committee on social workers – methodologists
- Committee on social projects
- Committee on social services for homeless people
- Committee on social services for seniors
- Healthcare committee

CARITAS SERVICES

A total of **1,446 services** were provided within the nationwide Caritas "family" in the course of 2019. Social services are registered pursuant to Act No. 108/2006 Coll., on Social Services. These services are broken down into three types: **1. specialised social counselling centres, 2. social care services, 3. social prevention services**. In the overall list, we also include: **4. healthcare services, 5. hospice services. We rank other services**, i.e. supplementary and supporting services, that do not fall within these categories as the sixth type.

SPECIALISED SOCIAL CONSULTING CENTRES

Counselling-centre employees assist users in dealing with government offices, mediate assistance, focus on labour-law relations, housing, family, interpersonal and property-rights relations, defence of people in need and other social and legal matters.

Caritas has **81 specialised counselling centres**, which provided a total of **174,562 interventions (contacts)** to **44,568 individuals**. The numbers of contacts and interventions in various areas of counselling are shown in the table.

Two-thirds of counselling centres also provide **debt counselling**, the volume of which corresponds to one-third of all interventions provided in connection with civic counselling. Social workers help clients with orientation in the situation, and together they attempt to set up payment calendars or apply for debt relief. A total of **12,920 people** turned to Caritas with debt problems, of whom, on average, every sixth filed a **petition for remission of debt (2,248 in total)**.

Approximately one-tenth of clients (**1,261**) were facing bankruptcy, but **they could not apply for remission of debt** due to the mandatory repayment limit of 30% of outstanding debts or because of an unrecoverable amount that was too low. Based on these experiences, **Caritas supported an amendment to the Insolvency Act** that would eliminate these barriers and significantly extend the possibilities for remission of debt. **The amendment came into force on 1 June 2019.**

To preserve the natural home environment

SOCIAL CARE SERVICES

Caritas's services provide support and assistance to people who are unable to take care of themselves due to health limitations or disabilities and, at the same time, cannot be assisted by family members or other loved ones. These forms of assistance are part of **social care services**, of which Caritas operated **359** in 2019 and

which involved **26,789 clients**. In particular, this involved a **field care service** and **personal assistance**, as well as **emergency care** and **support for independent living**. **Relief services** help people who have decided to take care of their loved ones. **Daily and weekly short-stay** and **day-care service centres** are also available. If circumstances

do not allow users to remain in their natural home environment, a number of **residential services** are offered: homes for seniors, homes with a special regimen and sheltered housing services. In terms of scope, the most significant are **field care services**, which were provided by **1,741 caregivers** to **18,312 clients**; a total of **3,858,875 interventions** were carried out.

To offer shelter and support

SOCIAL CARE SERVICES

This includes **376 registered services** with a total of **44,645 users**. These services help people who find themselves in a crisis situation due to their addictions, lifestyle or socially disadvantaged environment. Among other things, they also protect society from the spread of undesirable social phenomena.

One such group comprises **homeless people**, who find immediate assistance, such as the possibility to bathe, eat and rest, **at low-threshold day-care centres**. In 2019, Caritas Czech Republic recorded **213,912 visits** and **329,983 interventions**, during which issues such as loss of housing, employment or documents were addressed.

One-off assistance and places to sleep can be found in **hostels**, which attempt to motivate clients to use related social and public services. **Shelters** help clients cope with their generally difficult social situation and provide accommodation for the absolutely necessary period. Contracts were concluded with **1,462 persons** at Caritas shelters in 2019.

Shelters for mothers and, as the case may be, fathers with children in need provide refuge for mothers (and fathers) with children in distress. In 2019, a total of **3,458 parents and children** comprising **1,223 families** were afforded housing in these shelters. **Field programmes**, which carried out more than **93,000 contacts and interventions**, are also important in the long-term fight against poverty and social exclusion.

Social activation services for families with children and for seniors and disabled people operate in the field. **Low-threshold clubs for children and youths** offer space for children and young people from disadvantaged backgrounds: in 2019, these clubs were visited by **7,615 children** and adolescents. **Early care services** are crucial for families with children whose development is at risk. Individual services and figures are shown in the table.

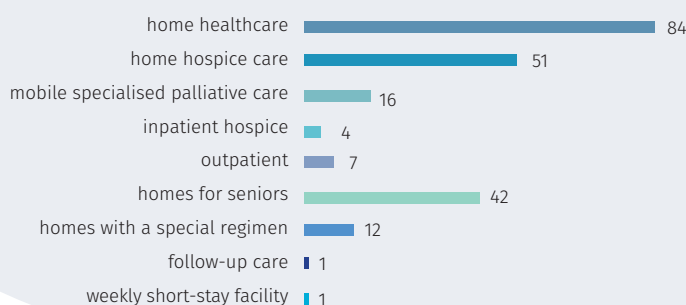

HEALTHCARE SERVICES

We are the biggest non-governmental provider of healthcare services in the Czech Republic. We provide these services at **218 healthcare facilities** (see graph 1), where **1,582 nurses work** (see graph 2); care was provided to a **total of 54,972 patients** in 2019 (see graph 3).

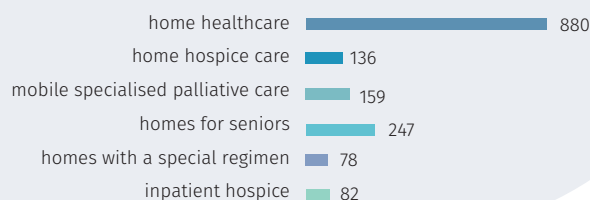
Caritas facilities with healthcare services

(total 218)



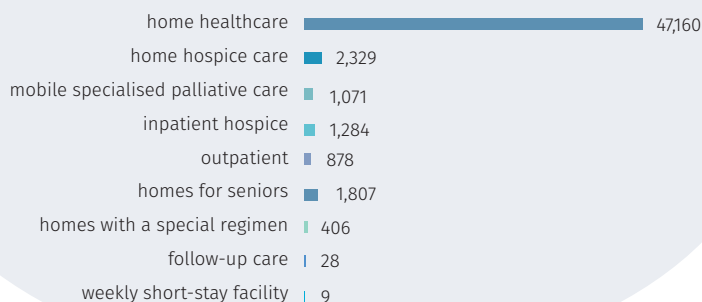
Nurses working in Caritas

HOME HEALTHCARE

We have been providing home healthcare for more than a quarter of a century. We operate **84 centres**, at which **880 nurses** worked in 2019, treating **47,160 patients**. In 2019, most of the centres faced financial problems caused by insufficient payments

and regulations from health-insurance companies. We had repeatedly – and unsuccessfully – brought the underfunding of this form of care to the attention of both health-insurance companies and the Ministry of Health of the Czech Republic. The reversal

of this protracted situation, which placed home healthcare at risk of collapse, was aided by the **Home is Home summer petition drive** (about which more information is available on page 2), after which it was possible to secure adequate funding for 2019 and the following year.

HEALTHCARE IN RESIDENTIAL FACILITIES

A total of **325 nurses** worked at **54 residential facilities** – homes for seniors and homes with a special regimen – with capacity of **1,677 beds**. Last year, **2,213 clients**, who required **nearly 700,000 medical procedures**, stayed in these facilities. A total of 317 clients died in the course of the year. The residential facilities took advantage of newly enacted possibility – in addition to nurses, they also began to employ general-practice nurses. Eighty-six nurses were added, thus improving the residential services, as evidenced by the decrease in the number of deaths (148 fewer than in the previous year). We will continue to strive to **improve the accompaniment of dying clients of residential facilities**. Our goal is for such clients to be able to die at home without the necessity of hospitalisation at the end of their lives. At the same time, Caritas's residential services **continue to face health-insurer regulations in the amount of CZK 8.8 million**, a deficit that is 50% higher than in the previous year.

HOSPICE SERVICES

Home hospice care and mobile hospice care

The mission of Caritas nurses is also to accompany the dying in the last months of life. Caritas Czech Republic has **51 home hospice care centres**, where **136 nurses** work. Over the course of the year, the provided care for **2,329 people**.

A total of 159 nurses work in **16 mobile specialised palliative care teams**. Over the course of the year, they took care of **1,071 patients**, each of whom was treated for 26 days on average. Only 1.63% of patients were hospitalised for serious complications.



Both teams providing this form of care for the dying have a rising trend: in 2019, the number of nurses increased and, at the same time, the number of patients receiving care doubled. Not all of the mobile specialised palliative care facilities have a contract with health-insurance companies, so one-third of the cost of their services is covered by sources other than public health insurance.

Residential hospices

Caritas Czech Republic operates **four residential hospices** with a total capacity of **140 beds**. In 2019, **82 nurses** took care of **1,284 dying people**. Residential hospices offer **116 relief beds** for patients whose families take care of them during the year: patients' loved ones can rest for a transitional period following demanding care.

Outpatient care

Caritas Czech Republic also operates outpatient services. In 2019, **106 patients** were treated at the **Hradec Králové outpatient pain-treatment facility**. We treated **316 patients** at the newly established **outpatient palliative medicine facilities in Hradec Králové and Olomouc**. We provided relief to **120 patients** at the **outpatient physiotherapy facility in Brno**.

Integration of Foreign Nationals

Services aimed at supporting new arrivals in need have been a part of the Caritas network since 1992. The foundation is provision of free specialised social and legal counselling related to other activities focused on assisting with integration. Caritas's services in this area ease the work of state institutions and contribute to the problem-free coexistence of the majority society and newcomers.

Caritas's counselling centres help clients in the social and legal areas, in handling matters involving residence permits, employment, housing and healthcare services. They also organise integration-focused Czech language courses, accompany clients to government offices (including meetings at the Department of Asylum and Migration Policy of the Ministry of the Interior), to schools and to doctors, and ensure interpreting and translation of documents.

In 2019, Caritas counselling centres focusing on new arrivals employed 121 workers with various areas of expertise – social workers, workers in the area of social services, attorneys, community interpreters, intercultural workers, Czech language instructors and others. The counselling centre in Prague had the largest number of employees – fifty in total.

INTEGRATION COURSES

Individual Caritas organisations organise low-threshold Czech-language and socio-cultural skills courses focused on integration of foreign nationals into society. **Czech language courses** were attended by **1,390 clients** and **integration-related socio-cultural skills courses** by **248 people**.

ASSISTANCE FOR RE-LOCATED COMPATRIOTS

We provide **comprehensive integration services to Ukrainians and Venezuelans with Czech roots** to whom the Czech Republic has offered **permanent residence and assistance with integration**. These services include assistance with finding housing and employment, mediation of contacts with doctors, enrolment of children in schools and provision of language and retraining courses.

ASSISTANCE FOR REFUGEES

Caritas has extensive experience with assisting refugees, i.e. applications for international protection and persons who have been granted international protection. In 2019, our clients included **206 persons from various countries** (e.g. Afghanistan, Armenia, Azerbaijan, Belarus, China, Cuba, Georgia, Iraq, Kyrgyzstan, Pakistan, Russia, Syria, Ukraine, Uzbekistan). In addition to **social and legal counselling**, we organise **leisure activities for children and adults** at the residential centres of the Refugee Facilities Administration.

Clothing is provided as an additional service. For persons who have been granted international protection, we provide **comprehensive assistance services**, e.g. help with finding employment, housing, doctors and schools for children.

MULTICULTURAL ACTIVITIES

We strive to ensure that the coexistence of migrants and the majority society is not accompanied by problems and misunderstandings. Therefore, we organise **events at which at which various cultures come together, as well as lectures and discussions for students**. Other activities include **school concerts for children and summer camps**. All of these meetings help to break down stereotypes and prejudices between the majority society and minorities. The biggest intercultural events include the **Meeting of Nations in Hradec Králové** and the **Summer Garden Celebration in Plzeň**. Caritas also loaned Jindřich Štreit's exhibition of photographs titled **We Are from the Same Planet**, which was successively put on display in České Budějovice, České Velenice, Plzeň, Kadaň, Velká Bystřice and in other locations.

VOLUNTEER WORK

In 2019, the Greek Catholic Caritas provided all of its services on a volunteer basis, primarily in Liberec, Prague and České Budějovice. **For the Ukrainian community, it organised cultural events and excursions**, and assisted with obtaining documents in cooperation with the representative office. **In the Hradec Králové and České Budějovice dioceses, volunteers tutored the children of foreigners** and organised summer camps for them.

ASSISTANCE INFOLINE

For a number of years, an Infoline has been available **for Mongolians, Vietnamese and Ukrainians throughout the Czech Republic who find themselves in a difficult life situation**.

The infoline assists them with understanding during doctor's visits, meetings at school and at government offices, as well as with filling out forms and translation of official documents, while offering contacts to other support services. Via telephone and the internet, it provides clients with interpreting, information and mental-health support, and **facilitates communication between foreigners and government offices and institutions**. In 2019, operators assisted a total of **1,313 clients** with integration into society. Operation of the service was supported in 2019 with funding from the integration programmes of the Ministry of the Interior in the amount of CZK 1,167,200 and the City of Prague contributed CZK 200,000.

MARIANEUM

Hotel and Training Centre

This building in the Vinohrady district of central Prague is equipped with halls and classrooms for organising conferences, training courses, lectures, workshops, roundtable discussions, meetings with partners and other events held by companies, non-profit organisations and state institutions. It also offers additional services such as refreshments, client service for hotel guests, etc. It is a partially barrier-free building (stair lift, elevator, specially designed room) with 28 single to triple rooms for 46 people, and a quiet garden is available in summer.

Following the structural renovation of the interior, which was completed in the previous year, the Marianeum underwent changes in 2019 that immediately spurred increased interest in accommodation and rental of training rooms. New personnel were instrumental in ensuring that the hotel services reach a professional level. The facility now provides breakfast to guests and several types of refreshment are provided for participants in connection with conference services. A new feature is the concierge service, which includes reservation of transport tickets, airline tickets, taxis, guides, etc. for clients.

The Marianeum also offers rental of spaces to long-term partners, e.g. Caritas Internationalis and the Faculty of Humanities of Charles University in Prague. It is also the venue of regular meetings of specialist colleagues from Caritas Czech Republic, as well as Caritas Europa.

Individual Caritas organisations and other educational and social institu-



tions and non-profit organisation use the Marianeum's conference halls for their events, i.e. lectures, training courses, workshops, etc.

The functionalist building was constructed just prior to the First World War. From 1914, it housed the Marianeum institute, which functioned as a "shelter for old ladies" and became part of the Catholic Caritas Association during the First Republic. The property was returned to Caritas after 1989.





Global Development Education

In connection with the foreign projects of Caritas Czech Republic, we strive for global responsibility also at the local level. By means of development education and raising awareness, we are initiating the creation of a world in which all people have the opportunity to live a dignified life. We call for critical thinking, openness and understanding between developed and developing countries. Through various activities, we present various Sustainable Development Goals (SDGs) to Czech society and draw attention to elements of everyday life, thanks to which all of us can partially take part in the fulfilment of those goals.

MIND

October 2017 – September 2020
CZK 2,432,554 (European Commission)

Within the **Migration – Interconnectedness – Development (MIND)** project, this involves **understanding the different ways of life of people in various places on the planet and elimination of stereotypical fears and prejudices.** The objective is to raise the awareness of the public, including politicians and journalists, about the relationship between migration, sustainable development and development aid.

Together with twelve European Caritas organisations under the common slogan **What is Home? (#whatishome)**, we organised discussions with journalists and experts and a press trip to Iraq; we focused attention also on youths (the Living Libraries series, creative competitions, etc.). We actively participated in roundtable discussions, conferences and panel discussions. In connection with advocacy activities, we published the study *Paths to Prosperity: Migration and Development in the Czech Republic*, which became part of the Europe-wide edition of the *Common Home* study.

Sustainable Towns and Municipalities for Development II

February – December 2019
CZK 1,189,110 (Czech Development Agency)

The ambitious goal of involving local governments in the fulfilment of **Sustainable Development Goals (SDGs)** brought us together with the Union of Towns and Municipalities of the Czech Republic. Project participants included representatives of ten towns and villages (Rožnov pod Radhoštěm, Mníšek pod Brdy, Ústěk, Sázava, Kopřivnice, Bukovec, Havířov, Vejprty, Prachatice and Třebíč) who completed several trainings on the issue of global responsibility so that they could prepare **educational events for the public** on these topics and enhance their knowledge of project management and grant fundraising. Thanks to that, in cooperation with local residents, associations and companies, many **globally responsible activities, events and campaigns (Health Day, Food is Not Waste, etc.)** were created for certain residents of partner cities and municipalities. The year-round work of the participating municipalities was presented at the final conference.



Humanitarian Aid

As in past years, humanitarian aid was dispatched primarily to the Middle East, where people still face the repercussions of protracted conflicts and the loss of essentials – the security of a home, sufficient food and water, medical care and the opportunity to work and study. In Cambodia, we help people to cope with natural disasters. Two projects are focused on the better ability of European and Asian Caritas organisations to respond to humanitarian crises.

IRAQ

Several years of fighting with the Islamic State in the Middle East have caused millions of people to subsist in a devastated land, often without a roof over their heads, healthcare or sources of income. There are still nearly 1.5 million internally displaced people in Iraq and more than four million people need humanitarian aid. We helped repair damaged houses and build shelters, strived to improve access to healthcare and to support children's education.

3D printed medical supplies for medical facilities in the Ninewa Governorate in Iraq

June 2018 – February 2019

CZK 238,016 (Ministry of the Interior of the Czech Republic – Medevac programme)

In order for people affected by the fighting in the Middle East to be able to return home, it is necessary, among other things, to ensure the provision of healthcare in the affected areas. In hospitals in the Ninewa Governorate, this meant costly repairs or the purchase of new medical equipment. A less expensive and more efficient option was brought forth by a Caritas project in which needed components were manufactured using a 3D printer. We first equipped and trained the startup company Mosul Space and then successfully repaired eleven devices, such as incubators. We also supplied components and necessary medical equipment to other local hospitals and healthcare centres.

Emergency humanitarian assistance for vulnerable internally displaced families in Berseve 1 Camp, Iraq (Kurdistan)

July 2018 – February 2019

CZK 5,804,764 (French Foreign Ministry, Secours Catholique – Caritas France, Three Kings Collection)

Following the end of hostilities, approximately 8,700 people, mostly Yazidis, live in the Berseve 1 refugee camp in northern Iraq. Our project was focused on improving hygienic conditions for the camp's residents, primarily by building latrines and raising people's awareness of hygiene measures. In cooperation with a Caritas France organisation, 800 new latrine blocks were set up in the camp. Furthermore, we involved the camp's residents in the project by means of the cash-for-work method – they received an opportunity to earn extra money in connection with the construction and maintenance of the latrines.



Increasing access to sustainable and quality healthcare services for returnees and vulnerable communities in Al Qa'im district, Governorate of Al Anbar, Iraq

November 2018 – May 2019

CZK 9,352,553 (Ministry of the Interior of the Czech Republic – On-the Spot Assistance Programme)

Governorate of Al Anbar in western Iraq has been severely affected by the fight against the Islamic State and nearly half of its population has fled. The war also impacted a hospital in the city of Al Qa'im, which was destroyed by militants along with its equipment. In cooperation with the Iraqi government, our goal was to put the hospital back into operation so that it could be used by people who return to the province after the war. Within the project, we performed a detailed damage analysis and purchased the necessary medical equipment. In addition to that, we organised nine trainings for hospital personnel so that they could learn how to work with the new equipment.

Improve living conditions and enhance resilience of most vulnerable returnee families through shelter rehabilitation in Hamdaniya District in Ninewa Governorate, Iraq

May 2019 – December 2019

CZK 9,000,000 (Czech Bishops' Conference)

People who fled the war and the violence of the Islamic State in the vicinity of the ancient Assyrian city of Qaraqosh (Arabic al-Hamdaniya) in northwestern Iraq began to return. However, they often find their homes destroyed and basic infrastructure and services are lacking. Thanks to our help, 32 families have now been able to return to safe and newly repaired homes. The project thus helped a total of 192 people in a difficult socio-economic situation.



Mediation and peaceful resolution of HLP disputes, support to housing, land and property rights for IDPs in Ninewa

July 2019 – February 2020

CZK 2,524,848 (UN-Habitat programme, humanitarian collection of Caritas Czech Republic)

Among other things, years of violence and conflict in Iraq have caused numerous disputes over property and land which are difficult to resolve due to insufficient documentation and the complicated economic situation. One solution is sensitive negotiation. In cooperation with the UN-Habitat programme, we trained 14 negotiators of various ages, ethnicities and religions who then assisted with the non-violent resolution of 356 disputes involving land or property claims.

Improve living conditions for vulnerable IDP families in Kabarto 1 Camp through continuous and quality supporting primary healthcare centre

July 2019 – February 2020

CZK 4,261,886 (Secours Catholique – Caritas France, Humanitarian Collection of Caritas Czech Republic)

At Kabarto 1 camp in the Daquq District of Iraq, 13,500 people, mostly Yazidis, live in makeshift tents. The only medical centre for the entire camp had to be closed due to a lack of funding. In cooperation with a Caritas France organisation, we therefore restored the centre's activities and also ensured the engagement of necessary healthcare workers for provision of primary care and care for pregnant women and new-borns, and even a dentist.

Improve national education and support the retention of schoolboys and girls in education through the implementation of national school feeding programme in Daquq District

September 2019 – May 2020

CZK 3,504,743 (World Food Programme)

One of the key tasks for normalisation of the situation in Iraq is to ensure regular school attendance of all children. In the Kurdish Daquq District, we therefore ensured the distribution of packages of healthy food to schoolchildren. A total of 18,000 children at 111 schools are involved in the project, which also focuses on sharing information on hygiene. Furthermore, the project employs local residents and supports local food suppliers.

Emergency shelter and NFI assistance to improve living conditions of most vulnerable families in Iraq

October 2019 – July 2020

CZK 9,728,250 (UN Office for the Coordination of Humanitarian Affairs)

The situation of people who fled the Islamic State and are now returning home remains critical. Our project is focused on the Daquq, Kirkuk and Saladin governorates, where it helps more than 25,000 residents through distribution of essential hygienic products and sealing-off kits, i.e. packages containing material and tools for repairing and constructing temporary housing. Furthermore, some of the local people can participate in the projects, thus gaining meaningful employment and a source of income for their families.



CAMBODIA

Cambodia is regularly affected by flooding and long-lasting droughts. Frequent flooding during the monsoon season destroys school buildings and residences and has an impact on the lives of hundreds of thousands of people, especially those in rural areas, who are dependent on their own agricultural production. During times of drought, people suffer from a lack of clean water, which poses health risks, and of course their crops are also imperilled.

Building resilience and disaster preparedness on community level in Kampong Chhnang province

April 2019 – December 2019

CZK 2,395,691 (Czech Development Agency, implementation partner of Caritas Cambodia)

We helped selected schools and villages in Kampong Chhnang province to improve their ability to respond to natural disasters and other life-threatening situations. We prepared workshops for students, teachers, school principals and representatives of local village councils, at which they obtained information about risks and then were able to practice their responses in specific model situations. The work resulted in the development of contingency plans describing the procedures to be carried out in the event of a natural disaster. These plans took into account the situation and possibilities of the relevant school or village. The project also included assistance in obtaining potable water for local schools by purchasing pumps, filters, storage tanks, etc. In addition to that, children learn how to grow organic vegetables in the newly built school gardens.



EUROPE, ASIA

On our continent and in the countries of the global south, the need to improve and coordinate the work of humanitarian aid workers and volunteers is increasingly apparent. Well-planned cooperation helps to reduce damage and the loss of life when disasters occur.

TEACH – EU Aid Volunteers: Technical assistance for European Caritas organisations in humanitarian aid

February 2018 – January 2020

CZK 1,854,681 (European Commission)

This project is focused on improving the work of European Caritas organisations that provide humanitarian aid. Thanks to the project, we can share experience with colleagues from Belgium, Austria, Romania, Ireland and Great Britain and establish cooperation with them in the area of humanitarian aid. In workshops and campaigns in the Czech Republic, we focused on disseminating information on humanitarian aid and on foreign missions of Caritas Czech Republic. In addition, we drew attention to EU Aid Volunteers, an international volunteer programme for youths and adults.

PEACH II – EU Aid Volunteers: European-Asian Partnership for building capacities in humanitarian action II

April 2018 – March 2020

CZK 524,492 (European Commission)

In cooperation with Caritas Austria and Caritas Romania, we are striving to improve the preparation and organisational skills of Asian Caritas organisations (Nepal, India, Myanmar, Bangladesh, Indonesia, the Philippines, Pakistan, Mongolia and Caritas Asia) in connection with humanitarian disasters such as earthquakes and floods. In connection with the improvement of work with volunteers, Caritas Czech Republic took charge of creating a database of volunteers, which is helpful for all participating organisations.



Development Cooperation

Under the name Caritas Czech Republic, we operated on various continents in 2019, particularly in the areas of healthcare, social care and agriculture. However, we also supported agriculture and the development of small business and civil society. We pay attention to environmental protection and respect for human rights, while focusing on strategic and sustainable development.

GEORGIA

Our team in Georgia focuses particularly on health and social care; other major issues are agricultural and rural development including natural-resources management, support for community life and building a stronger civil society. Caritas Czech Republic currently has an office in Tbilisi and a regional branch in the Khulo Municipality in Adjara.

Promotion of rural development and diversification in Khulo Municipality

May 2017 – February 2021

CZK 10,952,858 (European Commission – ENPARD, Czech Development Agency)

This project, which is focused on developing the local economy and improving living conditions, had a positive effect on the lives of nearly 24,000 people in the poor mountainous region in the western part of the country. The local action group is developing a strategy for the sustainable development of the area. The local economy is supported by a system of grants for small businesses and producers; in addition to that, farmers and businesspeople can benefit from trainings in which they learn to use resources and to plan their business so that their products succeed on the market.



Launch of quality improvement for primary health care system in Georgia

June 2017 – December 2019

CZK 4,681,084 (Czech Development Agency, Three Kings Collection)

In close cooperation with the relevant Georgian ministry, where a department dedicated to improving the quality of care was established, we worked on this project focused on primary healthcare, treatment of childhood leukaemia and better prognoses in patients with non-communicable diseases; two specialists had the opportunity to familiarise themselves with primary care in the Czech Republic. At five medical facilities in Tbilisi, we trained employees who tested an effective data collection system. The introduction of a new payment model contributed to the fact that family doctors have actively got involved in preventive care and have started to provide a wider range of services for insured persons.

Establishment of children's long-term and palliative care services in Georgia

November 2017 – December 2019

CZK 1,331,450 (Czech Development Agency, Three Kings Collection)

In cooperation with the Georgian Ministry of Health, we developed standards of services

for children requiring long-term or palliative care. We created educational materials for healthcare personnel and, with their help, we trained 200 employees of public and private clinics in the regions. We also trained the staff of the newly established Centre for Paediatric Long-Term and Palliative Care at the Zhvania Paediatric Hospital in Tbilisi; in addition to that, a Snoezelen therapy room was established at a children's hospice and the staff was also trained in providing treatment using this method of multisensory stimulation.

Development of sustainable waste management system in Pshav-Khevsureti protected area and adjacement territories

December 2018 – November 2019

CZK 810,588 (UN Development Programme, Three Kings Collection)

Based on a proposal by Czech experts and on other experience gained abroad, an innovative solution for sustainable and effective waste management was created in the Pshav-Khevsureti National Park in the Dusheti area. Furthermore, the Dusheti Municipality incorporated the plan approved by the Agency of Protected Areas into its waste-management system.

Delivery of medical equipment for selected wards of Children's Hospital in Zhvania

January 2019 – May 2019

CZK 3,905,029 (Czech Development Agency public tender)

Part of the public tender involved the purchase of medical equipment and training of the relevant departments' personnel. At the same time, awareness was raised with respect to the Czech Republic's foreign development cooperation and humanitarian aid in general.

Setting long-term accessibility of national screening programmes in Samegrelo region

January 2019 – December 2021

CZK 4,445,649 (Czech Development Agency, Three Kings Collection)

With this project, our work in Zugdidi continues: following the completion of construction of the new screening centre, it is now necessary to supply the remaining equipment, put the facility into operation and promote its screening services. The creation of financial and quality control mechanisms will ensure that the provided services correspond to medical standards. The centre was integrated into the national oncology registry and launched several pilot screening programmes. Thanks to the project, every year 1,000 women can undergo breast cancer screening, 1,000 women can receive cervical cancer screening and 800 men and women can be screened for colon cancer.

Improvement and expansion of services for individuals with autism spectrum disorder in Georgia

June 2019 – June 2021

CZK 3,158,000 (Czech Development Agency, Three Kings Collection)

This project builds on our previous work for people with autism spectrum disorders in Georgia: this time it involves the professional growth of specialists who can diagnose such disorders and then work with clients. We trained more than 250 specialists, who are aided by new diagnostic tools and methods in examining more clients and providing them with necessary services. In addition to that, fifteen therapists completed a newly developed certified training programme in applied behavioural analysis (ABA), thanks to which services for children with autism will now be available in the Samtskhe-Javakheti and Guria regions. We are collaborating with the Ministry of Health on the introduction of national standards of services for people with autism spectrum disorders in six regions of Georgia.



CAMBODIA

Cambodia ranks among the poorest countries in Southeast Asia. A large number of its people, particularly in rural areas, live at or near the poverty line and have limited access to public infrastructure. Therefore, our projects are focused on, among other things, increasing the availability of high-quality healthcare, primarily neonatology and paediatrics.

Improving quality of maternal and child healthcare services in three hospitals in Kampong Chhnang province

April 2019 – December 2019

CZK 7,243,000 (Czech Development Agency, implementation partner Caritas Cambodia)

Six thousand infants die in Cambodia every year due to insufficient healthcare and poor hygiene. Therefore, this project of Caritas Czech Republic is focused on improving obstetric, neonatal and paediatric care by training physicians and obstetric assistants in Kampong Chhnang province.



MOLDOVA

In Moldova, we focus on home care, health-care, development of civil society, agriculture and support of livelihoods and social inclusion. Our projects are focused on the development of available and high-quality social services, the operational and financial sustainability of the home care services sector, the involvement of volunteers and interns, increasing the capacities of specialists and coordination of primary healthcare services on both banks of the Dniester River.

Support and assistance to the social sector in Moldova

January 2017 – December 2020

CZK 6,943,055 (Czech Development Agency, Three Kings Collection)

This project contributes to the decentralisation and deinstitutionalisation of the social sector and has the aim of increasing the quality and sustainability of social services. The result was a proposal for new tariffs for home healthcare services and a concept of legislative amendments that

would ensure payment for social services from the state budget. The proposal submitted to the relevant ministry was adopted as a plan for further reform. A programme was established involving internships and materials connected with strengthening cooperation between state and non-state institutions in the management of social services at the local-government level. Representatives of local authorities, non-governmental organisations, social organisations, etc. also participated in study-related travel to the Czech Republic.

Day workshop center for applied creative work in Bender

January 2018 – April 2019

CZK 532,708 (Three Kings Collection)

This project was focused on children, particularly on providing a suitable environment for the development of their skills and also on their social inclusion. The day centre was thus able to provide food for 20 children, organise a workshop called Artful Hands, in which they could develop their creativity, and activities focused on spirituality and Christian themes. The summer programme, which was conducted by teachers and volunteers, offered children swimming, excursions and cultural events.

Ensuring the quality and accessibility of medical-social homecare services in the Republic of Moldova 2019–2022

May 2019 – December 2022

CZK 7,370,000 (Czech Development Agency, Three Kings Collection)

This project, which is focused on increasing the quality and availability of home care services, supports the development of the capacity of local non-profit organisations. In addition to that, its objective is to amend the relevant legislation. Based on an analysis conducted in the preparatory phase of the project, recommendations for legislative amendments will be submitted to the relevant ministries. The project will help member organisations of the local partner association Homecare to increase capacity in providing high-quality and accessible services. In 2019, two new centres were opened and eight existing centres obtained new equipment.



MONGOLIA

Even though a significant part of the population is still engaged in traditional pastoralism, the economy has been gaining strength in recent years, thanks primarily to the development of the mining industry. However, rapid industrial development is linked to pollution and insufficient protection of the environment and natural resources. Therefore, our projects continue to focus on recycling and sustainable waste management. We also take into consideration the country's rural areas, which are lagging behind the cities in terms of development, and we support local farmers and small businesses.

Improving resource-efficiency and cleaner production in the Mongolian construction sector through materials recovery

February 2016 – July 2020

CZK 8,146,040 (European Commission)

The Mongolian construction industry has developed rapidly in recent years, but the management of construction waste is still a problem with respect to ecology and efficient use of materials. Therefore, our team developed a prototype building material that uses recycled construction waste and we are supporting its further research in collaboration with universities in Mongolia and the Netherlands. Within the project, we are also training Mongolian construction companies in the area of more environmentally friendly waste management and we are working to improve the country's legislation.

Strengthening CSOs-LAs partnerships in the agriculture sector in Khentii Province

February 2016 – March 2019

CZK 3,612,215 (European Commission)

Mongolia's rural areas often stand apart from economic and social events, mainly due to the vast distances between individual areas and poor infrastructure. Therefore, we focused on the province of Khentii, where we successfully completed a project supporting local agricultural production. We supported selected farmers and their business with direct grants, and we built two training farms and several greenhouses. In addition to that, a longer-term agricultural development strategy was completed in cooperation with local authorities, so that the province's development will continue even after the termination of project.

ZAMBIA

Despite Zambia's developing economy and copious natural resources, more than half of the country's population, the majority of which in rural areas, lives below the poverty line. Zambia is also a frequent destination for refugees, primarily those from the Democratic Republic of the Congo. Approximately one-fifth of them come to the capital, Lusaka, where they can stay, but without any social security and the legislation does not allow them to be employed. In refugee settlements, the main means of subsistence are crops, livestock and small business, but it is difficult to build up a prosperous business due to insufficient capital and other obstacles.





Agribusiness for LIFE – Livehood, Innovation, Food and Empowerment

July 2018 – July 2021

CZK 7,847,257 (Czech Development Agency, Three Kings Collection)

This project is focused on cooperatives and medium-sized farms in the Mongu, Limulunga, Kaoma and Nkeyema areas of the Western Province and the Mumbwa district in the Central Province with the aim of helping aid recipients to run their businesses productively and profitably. In addition to that, the project supports female farmers. More than 10,000 farmers have free access to the Lima Links mobile application, which provides information on market prices and customers. Specialists from the Czech University of Life Sciences in Prague are working on diagnostic and monitoring systems, and cooperatives receive weather information via a mobile application from the Czech company Big Terra Alpha. In 2019, we trained 125 farmers and 22 cooperatives on the issues of public administration, cooperative regulations, and other rules and regulations. Additional training was provided in the area of value chains focusing on cassava, rice and legumes, as well as food-processing technology and diversification of agricultural production.

Farmers capacity building focusing on value chains development

November 2018 – November 2019

CZK 1,400,000 (Czech Development Agency, Three Kings Collection)

This project is for farmers who want to transition from self-sufficiency to entrepreneurship: this involves financial literacy, management and marketing skills and the formulation of their own business plans, the evaluation of which is followed by fine-tuning, market analysis and drafting of a marketing strategy. After trainings focused on the value chains of local agricultural commodities and familiarisation with technologies and innovations, 35 farmers drafted their own business plans. Representatives of Czech and Zambian authorities, organisations and academic institutions, including Caritas Czech Republic, then selected the five best plans and for each of them a market analysis was prepared with recommended marketing and business strategies and technical and investment solutions.

Enhancing education (Lusaka) and livelihoods of refugees and their host communities in Lusaka, Mantapala, Meheba and Mayukwayukwa

January 2019 – December 2019

CZK 18,020,508 (UNHCR), additional CZK 2,895,422 (Czech Development Agency)

For approximately half of the refugees in Zambia, agricultural production is their primary means of subsistence, though there are also small merchants, craftspeople, healthcare workers and teachers in the camps. The aim of the project is to improve their self-sufficiency, facilitate access to agricultural production, fishing, small business and education. It also includes a programme to support the livelihoods of refugees in Lusaka, which is financed by the Czech Development Agency and, to some extent, builds on UNHCR's previous work in the refugee community. The programme ensured for families access to basic social services and vocational training and supported them in business. In addition to that, it ensured the operation of community centres with children's corners and literacy courses, while also offering socially disadvantaged people financial support and contributions to cover children's tuition fees.

Chiefdoms for savings – financial inclusion through traditional leadership

January 2019 – December 2019

CZK 1,723,539 (FSD Zambia, Three Kings Collection)



In Luapula Province, 80% of the population lives below the poverty line. In rural areas, far from the district centres, traditional administrative structures and leaders still play an important role. Because the commercial financial sector does not offer services to low-income villagers, this project fills the gap by supporting informal saving groups associating people who save. Their services are accessible, affordable and trustworthy for local people. By involving traditional leaders and village structures, we support financial literacy in five districts of Luapula Province through instructors who are able to train and initiate the establishment of saving groups. In the course of the project, we trained 15 instructors and 118 groups for joint saving were established with 2,491 members.

DAFI Scholarship Programme – tertiary education for refugees

April 2019 – December 2019

CZK 3,176,660 (UNHCR)

In Zambia, refugees can theoretically obtain permission to study at local universities, but they do not have access to government scholarships or student loans. Vocational and university education is very expensive. Therefore, in cooperation with the German Embassy in Lusaka, we supported 48 talented young refugees in gaining access to tertiary education through the DAFI (Deutsche Akademische Flüchtlingsinitiative Albert Einstein) scholarship. This involved payment of tuition fees and contributions to cover the costs of travel, books and housing, as well as career and psychosocial counselling provided by experienced consultants.

Zambia refugees and host communities improving access to goods and services through development of market area and capacity building of market committee at Mantapala refugee settlement

January 2019 – November 2019

CZK 940,208 (Good Neighbors)

It is necessary to finish the construction of infrastructure in the Mantapala refugee camp, including a marketplace at which locals can buy and sell vegetables and other products as well as non-food goods and provide minor services such as repairs, carpentry, dressmaking, etc. Within the project, we completed the construction of the Main Market in the centre of Mantapala and supported the establishment of a market committee.



Promoting the production and consumption of nutritious foods through an integrated multi-sectoral approach in Mumbwa, Kaoma and Mongu

May 2019 – December 2019

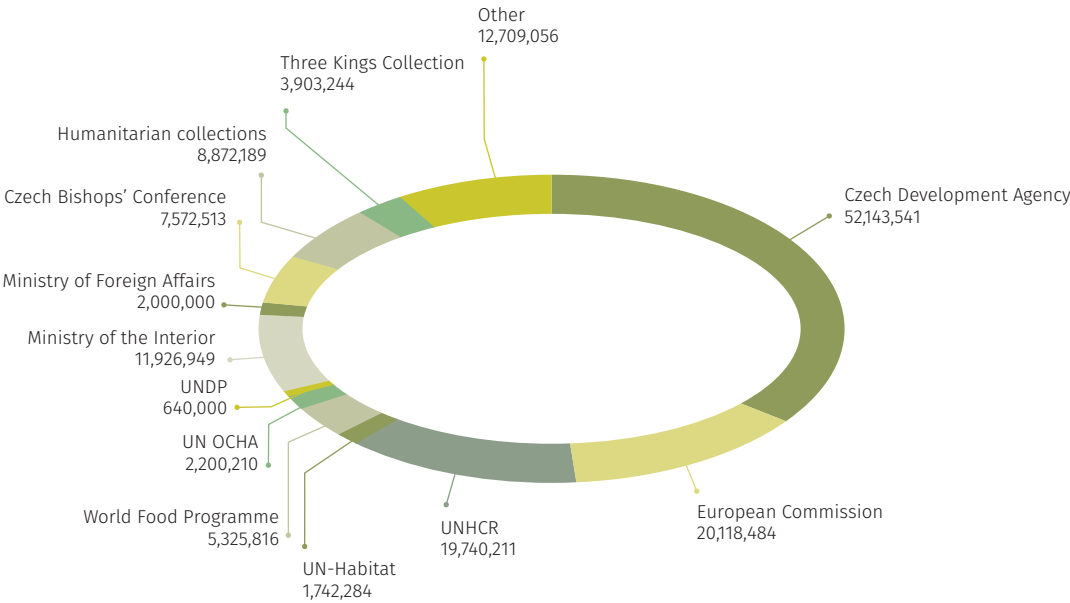
CZK 3,373,417 (World Food Programme)



Small farmers produce approximately 80% of all food, but more than 30% of it is degraded by poor storage and handling during harvest and transport. At the same time, children in Zambia continue to die mainly of malnutrition. Therefore, the aim of this project was to improve food security and nutrition for pregnant and breastfeeding women, adolescent girls, schoolchildren and farmers in the Mongu, Kaoma (Western Province) and Mumbwa (Central Province) districts by supporting diversified agriculture, increasing production, post-harvest management and better access to agricultural markets. The project provided support for 6,514 farmers, 9,478 schoolchildren, 2,110 pregnant and breastfeeding women and 1,327 adolescent girls.

Overview of International Projects

Ukraine

Field service in Melitopol and the surrounding area (social care and healthcare) – assistance for internally displaced persons, wounded persons and survivors, care for lonely and sick seniors and the socially disadvantaged.

Support for people in the Velykyj Bereznyj region (social care and healthcare) – care of homeless people, the poor, the elderly, the sick and otherwise socially needy people in the Transcarpathian region.

BRNO DIOCESAN CARITAS – ZNOJMO DISTRICT CARITAS

Ukraine

Assistance for poor families (material aid, social care) – material aid for poor families with children.

Treatment of children and adults (healthcare) – payment of treatment costs.

Support for parish Caritas organisations and the volunteer centre in Lvov – training of volunteers from parish Caritas organisations for social work.

Assistance for internally displaced persons in Zolochiv and Severodonetsk (material aid, social care) – social and material assistance for internally displaced persons.

Mary Ward Centre (payment of operating costs) – support for the operation of a halfway house and other assistance for needy children in the Pinsk Caritas's area of operation.

Children of the Street Crisis Centre (material aid, social care) – provision of food for children at the crisis centre.

Catechism and Rehabilitation Centre (social care) – support for the development of children with special needs (teachers, psychologists, rehabilitation workers).

Education of children and youths (education, social care) – support for the education of children and youths from poor families: purchase of teaching aids, payment of tuition fees, housing, food, etc.

ČESKÉ BUDĚJOVICE DIOCESAN CARITAS

Belarus

Long-Distance Adoption (social care) – financial support for children from fragmented and socially disadvantaged families with focus on improving their health and social situation.

Assistance for families with children suffering from cancer (social care) – financial support for a project of the Minsk Caritas enabling temporary housing for families with children suffering from cancer in the course of treatment; support for the Tabita relief service, which provides care for severely disabled seniors, adults and children.

Children of the Street (social care) – material and food aid.

Bulgaria

Stará Zagora low-threshold facility for children and youths (social care) – support for the activities of children and youths from the Roma community.

Zimbabwe

Long-Distance Adoption: renamed as the Donated Home in Zimbabwe (social care) – support for children from the Mary Ward Children's home in Kwekwe (payment of tuition fees, spiritual development, food).

India

Ukraine

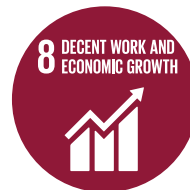

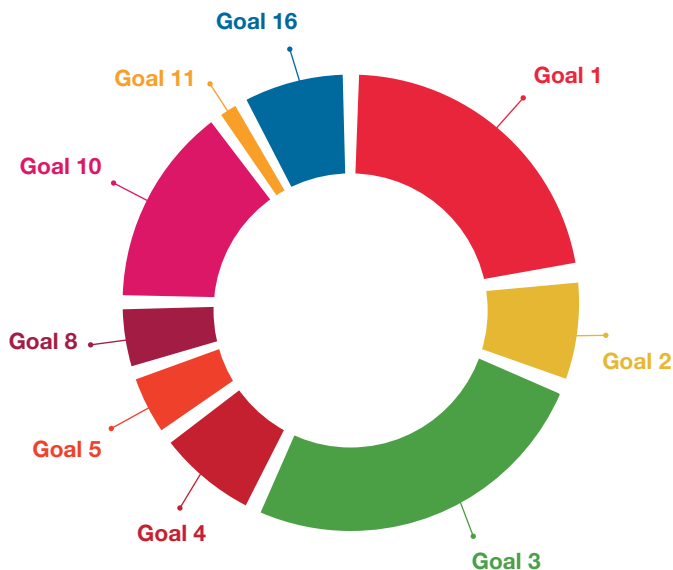

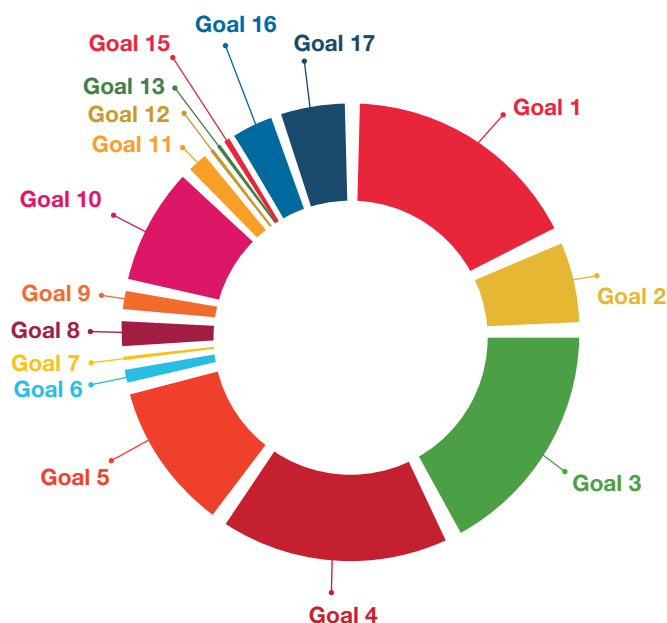

Financial Section

COMMENTS ON THE ECONOMIC RESULTS FOR 2019

The accounting unit differentiates the data in the profit-and-loss account according to principal activity and economic activity.

The principal activity consists in charitable activities carried out in connection with projects implemented in the Czech Republic and abroad, coordination and methodological support for agendas covering social and healthcare services, educational activities and promotion of charitable works. Individual activities are further categorised by department and order, by means of which separate accounting records relating to individual projects are secured. Financing of the principal activity is supported by the secondary economic activity consisting in the operation of the Marianum Hotel and Training Centre.

Economic activities in 2019 were influenced by a number of factors, one of the most important of which is the larger number of implemented projects of the department of humanitarian aid and development cooperation in comparison with 2018, which is closely associated with the cost growth connected with the implementation of projects in the areas of personnel costs and services. Another significant factor is the sharp upturn of secondary economic activities and the associated growth of operating costs as well as development and investment costs.

Compared to the previous year, costs grew by approximately 25% in total, though that figure is offset by the 13% growth in state subsidies, 12% growth in revenues from secondary economic activities and an increased share of cleared foreign subsidies and individual and corporate fundraising.

The total volume of costs for 2019 amounts to CZK 197,144,000.

The purchase of services and clearance of subgrants in connection with the implementation of projects in foreign missions in the amount of CZK 87,589 comprise the largest share in the organisation's total costs (44%).

Personnel costs in the amount of CZK 36,034,000, i.e. 18% of total costs, comprise the organisation's second most significant cost item.

Costs of services, repairs and maintenance in the principal and secondary activities related to administrative and development activities in the total amount of CZK 25,244,000 accounted for 13% of total costs. The largest volume comprised costs of professional services, office operations and operating costs in connection with secondary economic activities. Increased requirements for electrification, ongoing improvement of online communica-

tion, including the development and modernisation of information systems, also brought forth an increase of costs associated with IT services and licenses.

Consumed purchases in the amount of CZK 31,828,000 accounted for 16% of the organisation's total costs in 2019. The increase occurred particularly in the consumption of materials in connection with the implementation of projects and with the development endeavours of secondary economic activities. Energy consumption associated with the increased operation of the Marianum Hotel and Training Centre also grew.

Other costs, including, among other things, a significant amount of exchange-rate losses, depreciation and representation costs in the total amount of CZK 8,950,000 comprise 5% of the organisation's total costs.

In 2019, a total of CZK 3,189,000 (2% of total costs) was used for promotion and publicity. Travel costs comprise an equal share (approximately 2% of total costs) and the amount of such costs reflects project activities in foreign missions, which comprise approximately 85% of the total CZK 4,309,000. Within the Czech Republic, a number of business trips of professional personnel were carried out in the area of methodological support for social services of the Towards Quality in Caritas II project.

The total volume of revenues for 2019 amounted to CZK 192,058,000.

In connection with the principal activity, the accounting unit generates revenues primarily through subsidies in the total volume of 72%, public collections and other donations for the development of the organisation and its activities. Among public collections, sources include individual and corporate donors and comprised 15% of total revenues in 2019. Other sources to cover costs are the founder's contribution, donations to support the operation and development of the organisation and the organisation's resources derived from economic activities, which comprised 13% of revenues in 2019.

Revenues from the sale of services amounted to CZK 9,448,000, of which revenues from secondary economic activities comprised CZK 6,999,000, which is an increase of 61% in comparison with 2018. The clearance of public collections in relation to individual implemented projects and the provision of targeted assistance for the needy reached the total amount of CZK 27,814,000.

The total financial result before tax for 2019 is a loss of CZK 5,084,000. The economic result is affected particularly by large exchange-rate losses, which were caused by the significant instability of local currencies in the countries where foreign projects are implemented.

OTHER COMMENTED FACTS

Securities

Caritas Czech Republic owns securities that it inherited. No sales or purchases of securities occurred in 2019.

The securities were revalued on the basis of the exchange rate as at 31 December 2019. Their value declined by CZK 125,000 in comparison with 2018. A list of the securities is set forth in the annex to the financial statements.

Collections

In 2019, Caritas Czech Republic administrated three public collections on the basis of a permit from Prague City Hall granted for an indefinite period. The continual accounting of the collections, which is regularly submitted to Prague City Hall, is set forth in the annex to the financial statements.

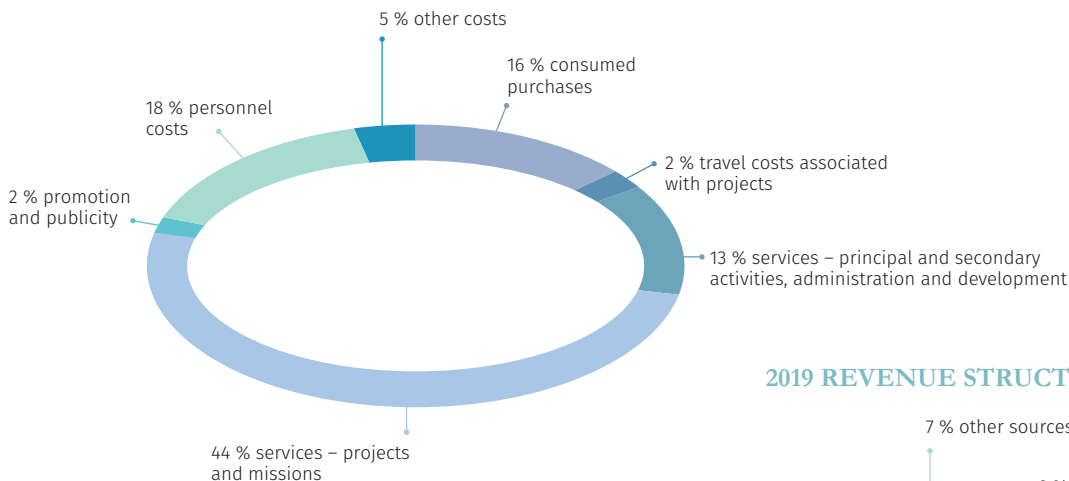
Auditor

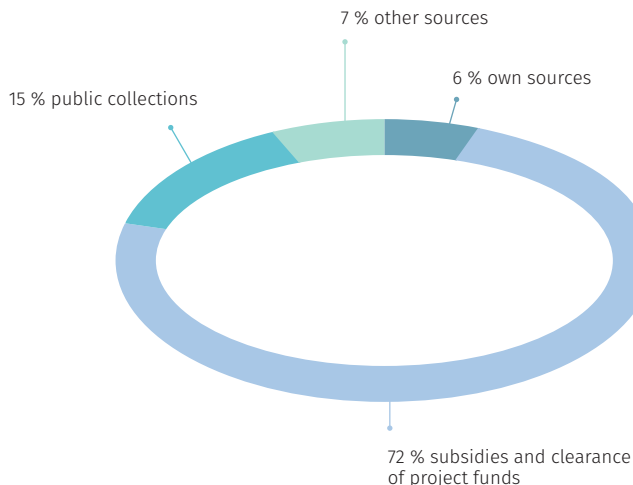

The organisation records tangible assets with a period of usability greater than one year and with a purchase price greater than CZK 40,000 in fixed tangible assets, entering them in the fixed assets accounts and reporting them in the balance sheet.

The organisation records tangible assets with a purchase price of less than CZK 40,000 in costs. Tangible assets with an acquisition cost greater

than CZK 10,000 but lower than CZK 40,000 with a period of usability greater than one year are recorded by the organisation in the operations records.

The organisation records fixed intangible assets with a period of usability greater than one year and a purchase price greater than CZK 60,000 in fixed intangible assets.

The organisation records intangible assets with a purchase price of less than CZK 60,000 in costs. The organisation enters intangible assets with a purchase price greater than CZK 10,000 but less than CZK 60,000 with a period of usability greater than one year in the operations records.

Interest is not included in the purchase price of non-current assets.

The organisation amortises structures for a period of 70 years. The organisation amortises automobiles for a period of five years.

The organisation amortises other, separate tangible assets for a period of five years.

II.3. Inventories

The organisation enters into accounting inventories purchased and created through its own activities at cost, including secondary acquisition costs.

II.4. Receivables

Receivables are valued at their nominal value upon their inception. In accordance with the decree, the organisation ordinarily does not create adjustment items. The director of the organisation may decide on the possible creation of an adjustment item.

The organisation enters into accounting the estimated items active in the case of subsidies pledged in writing for activities already carried out (reflected in costs), which, however, will be financially received only in the subsequent period.

II.5. Foreign-exchange transactions

For the conversion of data in foreign currencies into the Czech currency, including assets and liabilities, a fixed exchange rate is used as at the first day of the month according to the valid exchange rate of the Czech National Bank. The periodicity of changes in fixed exchange rates is one month.

II.6. Accruals

The organisation enters deferred costs in accounting. Through deferred costs, it accrues costs associated with later periods.

II.7. Non-current assets acquired free of charge

In equity on the account of group 901 – Equity, the organisation enters the sources of acquisition of non-current assets acquired free of charge. This amount is then discharged currently with the entry of amortisations.

II.8. Public collection

The organisation enters resources gained from public collections in the funds on account 911xxx – Funds from public collections (analytical differentiation according to individual collections). The organisation continuously enters the use of the proceeds by means of double-entry, debiting of the public collection fund to the benefit of account 6484xx – Clearance of public collections. The reported balance of the public collection fund corresponds to the unused amount from the public collection intended for later use, i.e. the balance of the collection bank account as at the balance-sheet date.

II.9. Received donations

The organisation enters in accounting received individual donations on the date of receipt in favour of fund 911 - Donation fund for the principal activity and debited from account 211 – Cashier or 221 - Bank account. The organisation continuously, or no later than the balance-sheet date, enters the use of donations from the fund by means of double-entry, debiting the fund to the benefit of account 648 – Other operating income (financial, non-financial). The reported balance of the individual-donations fund corresponds to the amount of unused donations.

II.10. Received subsidies

Received subsidies are funds provided from public sources, i.e. particularly from state budget sources, from the budgets of territorial self-governing units, from the budgets of foreign countries, etc.

When adopting decisions, the organisation enters funds from public sources in the Czech Republic in the liability accounts of group 34 and in revenues on account 691 – Subsidies. In the event that the entire received amount of a subsidy is not spent by the end of the year, the remaining amount is reported as a liability in the account of group 34 – Liabilities to the state budget. In the event that more is spent within the given subsidised project than has been received in connection with the subsidy, the organisation enters the estimated item, debiting account 388 – Estimated items to the benefit of account 691 – Subsidies, so that the financial result from the subsidy is always zero.

When adopting decisions, the organisation enters funds from foreign public sources in the accounts of 911 funds and they are entered in revenues against costs to the benefit of 648 - Other reve-

nues. In the event that the costs are higher than the fund, the organisation enters a receivable from a foreign donor in 378 – Other receivables.

II.11. Equity

II.12. Income tax

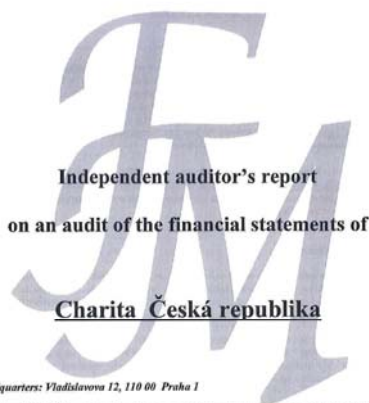

Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of *Charita Česká republika* (hereinafter also the "Association") prepared in accordance with accounting principles generally accepted in the Czech Republic, which comprise the balance sheet as at 31 December 2019, and the income statement, [statement of changes in equity and statement of cash flows] for the year then ended, and notes to the financial statements, including a summary of significant accounting policies and other explanatory information. For details of the Association, see the Note to the financial statements.

In our opinion, the financial statements give a true and fair view of the financial position of *Charita Česká republika* as at 31 December 2019, and of its financial performance and its cash flows for the year then ended in accordance with accounting principles generally accepted in the Czech Republic.

Basis for Opinion

We conducted our audit in accordance with the Act on Auditors and Auditing Standards of the Chamber of Auditors of the Czech Republic, which are International Standards on Auditing (ISAs), as amended by the related application clauses. Our responsibilities under this law and regulation are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Association in accordance with the Act on Auditors and the Code of Ethics adopted by the Chamber of Auditors of the Czech Republic and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Other Information in the Annual Report

In compliance with Section 2(b) of the Act on Auditors, the other information comprises the information included in the Annual Report other than the financial statements and auditor's report thereon. The Board of Directors is responsible for the other information.

Our opinion on the financial statements does not cover the other information. In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. In addition, we assess whether the other information has been prepared, in all material respects, in accordance with applicable law or regulation, in particular, whether the other information complies with law or regulation in terms of formal requirements and procedure for preparing the other information in the context of materiality, i.e. whether any

non-compliance with these requirements could influence judgments made on the basis of the other information.

Based on the procedures performed, to the extent we are able to assess it, we report that:

- The other information describing the facts that are also presented in the financial statements is, in all material respects, consistent with the financial statements; and
- The other information is prepared in compliance with applicable law or regulation.

In addition, our responsibility is to report, based on the knowledge and understanding of the Association obtained in the audit, on whether the other information contains any material misstatement of fact. Based on the procedures we have performed on the other information obtained, we have not identified any material misstatement of fact.

**Responsibilities of the Association's Board of Directors
for the Financial Statements**

The Board of Directors is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the Czech Republic and for such internal control as the Board of Directors determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the Board of Directors is responsible for assessing the Association's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Board of Directors either intends to liquidate the Association or to cease operations, or has no realistic alternative but to do so.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with the above mentioned laws and regulations will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with the above law or regulation, we exercise professional judgment and maintain professional scepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Association's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the Board of Directors.
- Conclude on the appropriateness of the Board of Directors' use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Association's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Association to cease to continue as a going concern.

- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with the Board of Directors, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.
